

FAQs

Q: How do I take care of my ticket without coming to court?

A: Go to Defensive Driving School for a “civil” traffic ticket, and complete it 7 days prior to your court date. Below is a link for further information and a listing of schools. www.azdrive.com

Or you may look in your local yellow pages

A: Plead guilty (criminal charges in court only) or responsible (civil traffic) and pay your fine in full.

Q: What if I can't afford to pay the whole fine?

A: Enter your plea to the court and ask for a payment plan.

Q: What if I want to pay my fine a month late?

A: If you have criminal traffic violations, the court may have issued a warrant for your arrest.

A: With civil traffic violations, your driver's license will be suspended.

Q: Can I pay my fine with a credit card?

A: Yes, you must call the court before your court date and we will be happy to assist you. We accept Visa, Mastercard, Discover and Amex

Q: Can I pay by personal check?

A: Yes, put your full name and citation number on the memo line of your check Made payable to: **Wickenburg Town Court.**

FAQs

Q: What if I want to plead not guilty?

A: Please indicate that by checking the appropriate box.

A: Make certain that your name, address and phone number are on your plea so the court can send paperwork to you.

Q: What happens after I plead not guilty?

A: For criminal traffic violations, you will be set for a pre-trial conference with the prosecutor.

A: For civil traffic, the court will set a civil traffic hearing for you.

Please note: By pleading not responsible you are waiving your right to attend defensive driving school.

Q: Will I get a receipt from the court?

A: Your cancelled check is your receipt.

Q: Can I pay online?

A: Yes, go to www.azcourtpay.com. You will need your complaint no. or case no.

Q: My car was impounded, where do I go to get it out?

A: Wickenburg Police Department

YOUR RIGHTS: You have the right to remain silent and to be presumed innocent until proven guilty. You have the right to have an attorney represent you at all phases of the proceedings, to cross examine witnesses against you, and present a defense. If you plead guilty, you give up these rights.

IMMIGRATION WARNING: If you are not a citizen of the United States, pleading guilty or no contest to a crime may affect your immigration status. Admitting guilt may result in deportation or removal, could prevent you from ever being able to get legal status in the United States, or could prevent you from becoming a United States Citizen.

Juveniles must appear with a parent or guardian.

Failure to appear in court on the date listed on your citation, or failure to complete one of the other options listed herein may result in the issuance of a warrant for your arrest, if a criminal traffic offense, or suspension of your driver's license for default on a civil violation.
